To: Ship Owners, Operators, Masters, Officers and Classification Societies

**Companies Approved as Application Service Provider (ASP) for the Implementation of LRIT**

1. This Guidance Notice gives details of an additional companies which has been authorised by Gibraltar as ASP's to carry out the Conformance testing and the issue of the necessary certificate. There is also a correction to the approval of Thrane & Thrane with the company name spelt correctly
2. Details of the company and the conditions under which it has been authorized are attached.
3. This brings to 5 the number of companies which have been authorised to provide this service. Owners and Operators are urged to ensure the equipment fitted on board their ships is tested and complies with the requirements as soon as possible.
4. **It should be noted that non compliance with the requirements for LRIT may have implications for ships which are trading into and out of the USA.**
5. Subject to further applications other companies may be approved, in which case this Shipping Guidance Notice will be re-issued.
